Directional Signs are intended to provide a safe and uniform means to direct the general public from the main traffic corridors of West Nottingham Township to establishments within the Township.

1. No sign shall be taller than 9 inches or wider than 36 inches. All signs are to be white letters on blue background and uniform in shape and shall only contain the name and direction of the applicant.
2. No establishment shall erect, place, install or maintain more than three signs within the Township and only one sign for each establishment shall be installed at any street intersection.
3. No more than three signs may be placed at any one corner of a street intersection. Co-location of multiple signs on a single post is required.
4. Directional Signs will be purchased, installed and maintained by the Township for uniformity.
5. The location of any Directional Sign shall be approved by the Road Master.
6. Township will bill the establishment an annual maintenance fee of \$0 per sign.
7. Signs will be removed upon the establishment's request or lack of payment of annual maintenance fee, or if the establishment shall cease to do business.
8. Signs must be for an establishment located within the Township only.
9. Change of name will require new sign application and fee.

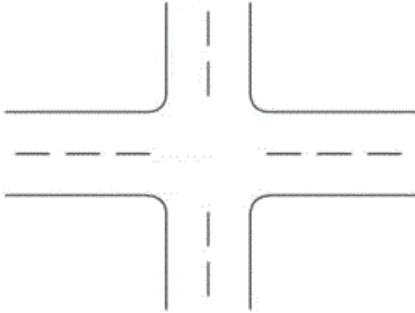

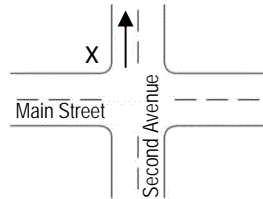
